States retain up to 50 cents on the dollar and forward the other 50 cents per head to the Cattlemen's Beef Promotion and Research Board CBB which oversees the national checkoff program. records of the sources of incoming ingredients, AB will specify that food facilities receiving food from community food producers and gleaners who collect food from multiple community food producers will have to keep records of the sources of incoming food for 30 days.
